

國立臺灣師範大學特殊教育學系「沈奕廷紀念獎學金」設置辦法

(100.11.22) 100學年第三次系務會議通過

(102.12.31) 102學年度第四次系務會議修正通過

一、緣起：為紀念本校特殊教育學系（後稱本系）大學部系友沈奕廷，並鼓勵清寒學生勤奮向學投身特殊教育工作，沈奕廷父親捐贈本系新台幣貳拾萬元設立獎學金。

二、名額：壹名。

三、金額：新台幣 10,000 元。

四、申請資格與條件：

- (一) 特教系大學部三年級學生。
- (二) 二年級學業成績平均達 GPA 2.93（含）以上，無記過處分或其他違規行為，且本學年未獲本校其他獎學金者。
- (三) 家境清寒者（低收入戶優先）。

五、申請時間及程序：

- (一) 凡符合本獎學金申請資格之學生，均可向本系提出申請，並備妥下列表格與資料：申請表一份、國稅局年度全家所得清單一份、二年級上下學期成績證明一份。
- (二) 本獎學金申請每學年辦理一次，於本系公告時限之內受理申請。

六、審查委員暨程序：由本系系務會議組成之。本系系辦彙整申請資料，提交系務會議評審，核定得獎名單後頒發。

七、基金保管及運用方式：

- (一) 本獎學金由本校獎學金管理委員會負責保管，每年由本金與利息作為獎金，若有剩餘利息加入本金。
- (二) 本獎學金之金額，必要時得由本獎學金審查委員會調整之。

八、本辦法經本系系務會議通過，提請獎學金管理委員會核備，並陳請校長核定後施行，修訂時亦同。

Regulations for the of the Shen Yi-ting Memorial Scholarship

Department of Special Education, National Taiwan Normal University

Approved by the 3rd Departmental Meeting of the 2011 Academic Year on November 22, 2011

Approved by the 4th Departmental Meeting of the 2013 Academic Year on December 31, 2013

1. **Background:** To commemorate undergraduate alumnus Shen Yi-ting of the NTNU Department of Special Education (hereafter the Department) and encourage economically disadvantaged students to study diligently and dedicate themselves to careers in special education, the father of Shen Yi-ting has donated NT\$200,000 to the Department as the Shen Yi-ting Memorial Scholarship (hereafter the Scholarship).
2. **Quota:** One student.
3. **Amount:** NT\$10,000.
4. **Eligibility and conditions:**
 - (1) Junior undergraduate students of the Department.
 - (2) Students who attained a GPA of 2.93 or higher in sophomore year without demerits or other violations who have not been awarded other scholarships from NTNU for the current academic year.
 - (3) Students from economically disadvantaged families (those from low-income households shall be prioritized).
5. **Application period and procedure:**
 - (1) Students eligible for the Scholarship may submit applications to the Department with the following documents: one copy of their application form, one copy of their annual income statement issued by the National Taxation Bureau, and one copy of their academic transcripts for the first and second semesters of their sophomore year.
 - (2) Applications for the Scholarship are accepted during one period per academic year before the deadline announced by the Department.
6. **Reviewers and review procedures:** Applications for the Scholarship shall be reviewed by the departmental meeting. The Department office shall compile the application materials, submit them to the departmental meeting for review, and approve the list of winners. The Scholarship shall be awarded accordingly.
7. **Fund management and utilization:**
 - (1) The Scholarship shall be managed by the NTNU Scholarship Management Committee. The capital and interest shall be awarded as the Scholarship each year, and the remaining interest shall be added to the capital.
 - (2) The amount of the Scholarship shall be adjusted by the NTNU Scholarship Management Committee as necessary.

8. These regulations and revisions thereof shall be passed by the departmental meeting, submitted to the Scholarship Management Committee for ratification, and promulgated after approval by the President of NTNU.
